The program is divided into six main blocks.

The program begins by laying the groundwork for what's to follow. Fundamental concepts of Law, Economics, Government, Corporate Governance, and Diplomacy are introduced as you begin to gain a broad vision of the key elements of global public and corporate governance. After laying the groundwork, you will deep dive into your chosen specialization. You will be able to tailor your studies to the areas that most interest you. This period moves into deeper analysis of critical global aspects.

2. Learning to apply core governance principles within the realm of complex organizations.
3. Becoming a purpose-driven global Leader to change the world.

6. Developing an expert voice in the key current debates by developing your master thesis.
